**Re: Follow-up Letter Regarding Board's May 25, 2007 Instructions for Cost Applications for the Yukon Energy Corporation's 20 Year Resource Plan and Power Purchase Agreement (PPA) with Minto Explorations**

Dear Ms. Lemke:

On May 25, 2007, Yukon Electrical submitted its Cost Application for the Yukon Energy Corporation's 20 Year Resource Plan and Power Purchase Agreement (PPA) with Minto Explorations. Subsequent to this submission, the Board issued instructions to parties that intended to make a cost application.

In our May 25, 2007 submission, Yukon Electrical provided complete details as to our involvement with the 20 Year Resource Plan through to the Pre-Hearing Conference as well as our involvement with the PPA. These details included:

- A cover letter and excel spreadsheet showing external legal costs incurred, external legal costs claimed and areas of involvement;
- Affidavit in support of the claim; and
- Copies of all legal invoices that detail the work performed.

While Yukon Electrical chose to withdraw from the 20 Year Resource Plan after our participation at the Pre-Hearing Conference, the preparation work incurred to that point was invaluable to our preparations for the PPA hearing.

For additional clarity, the costs broken out between the 20 Year Resource Plan and the PPA are as follows:
