Re: The Yukon Electrical Company's Intervenor Cost Award Claim regarding the Yukon Energy Corporation's Part III Application on the Carmacks-Stewart Transmission Project

Dear Ms. Lemke:

Pursuant to section 56 of the Public Utilities Act, the Board's Rules of Practice and the Board's Intervenor Costs Award Policy established on June 3, 2005, Yukon Electrical hereby makes application to be awarded costs incurred as part of the above noted proceeding.

As Yukon Electrical is the primary electrical distributor of wholesale and secondary energy supplied by Yukon Energy, Yukon Electrical actively participated in the Part III Application process. Specific areas of involvement include the following:

- Review of all applicable material included with YEC's 20 Year Resource Plan and Hearing,
- Review of YEC's Part III Application,
- Interrogatories to YEC,
- Attendance at the Part III Hearing, and
- Oral Argument.

Yukon Electrical's interrogatories and Oral Argument largely focused on the following areas:

- LOLE and N-1 Planning Criteria,
- Impact of Capital Cost Overruns on the Financial Viability of Stage One,
- WAF Customer Power Quality and Need for YEC To Adopt Dynamic System Power Quality Standards,
- Need for Stage Two of the CSTP, and
- Timing of Aishihik Third Turbine.

As evidenced by the above noted areas of focus, it is Yukon Electrical's position that its intervention was clearly for the benefit of ratepayers and was not predicated on a "sole business interest".

In summary, Yukon Electrical's cost claim is as follows:

In support of Yukon Electrical's cost award claim of \$350.01, we include the following:




