Attached please find YEC's Application for an Energy Project Certificate and an Energy Operation Certificate for the Proposed Carmacks-Stewart Transmission Project Cost Summary.

In determining the breakdown between "preparation", "attendance", "argument, reply and follow-up", Yukon Energy used the following basic organization:

- Preparation covers activities roughly to the start of the oral hearing on May 15, 2007 including the preparation of the application and the interrogatory response process.
- Hearing Attendance covers the immediate pre-hearing period and the hearing itself, preparation of undertakings and review of transcripts, etc. from approximately May 15 to 16, 2007.
- Argument, Reply and Follow-up covers all activities from the May 17, 2007 forward including the preparation of the final argument through to the receipt and review of the Board's report.

Pursuant to established practice for capital costs in the Yukon, YEC will defer and amortize the hearing costs of the Application for an Energy Project Certificate and an Energy Operation Certificate for the Proposed Carmacks-Stewart Transmission Project hearing over the life of the CSTP. This will include all costs incurred by the YUB and intervenors that YEC is directed by the YUB to pay.
